- 17. AMENDMENT TO THE LIQUOR CODE NEW LIQUOR LICENSE CLASSIFICATION.

Pollyanna Brewing (Roselare) and Lynfred Winery currently both have a Class E Liquor License that "Permits the retail sale and wholesale of wine and/or beer for consumption both on and off the premises specified". Pollyanna now distills spirits and would like to sell their product at Roselare, which would require the creation of a new liquor license. Staff has worked with the Village Attorney and proposes the following definition for a new Class U Liquor License:

Class "U" Licenses shall authorize the retail sale for on premise consumption of beer, wine and spirts. Beer may also be sold for off premise consumption in unopened original manufacturers containers or growlers or crowlers, which comply in all respects with applicable provisions of 235 ILCS 6-6.5. Spirits may be sold for off premise consumption but only if distilled by the Licensee and sealed in a container fully conforming with state law.

Mayor Pileski has been in contact with Relative Brewery, who would also like to apply for a Class U License. The annual fee for a Class E license is \$1,500 and the proposed fee for the new Class U License fee would be \$1,750. If the Board is supportive of the new license class and fee, ordinances will be placed on the June 28 Village Board agenda for final approval.
