There were 27 applicants for Battalion Chief. This has been narrowed down to the top 7 and will further be narrowed to the top 3.

There are 12 applicants for Deputy Chief.

Deputy Chief Kooistra provided an update on the number of applicants for the police officer exam. Chairman Toronyi asked if the applicants fell under the new eligibility rules requiring H.S. Diploma. D/C Kooistra noted they were under the new eligibility rules.


