

## Code Enforcement

The Code Enforcement Officer works with citizens to resolve issues that impact the quality of life in Roselle, including violations of the Zoning Ordinance and Property Maintenance Code. Enforcement is accomplished by routine inspections of commercial and residential areas, as well as by responding to citizen complaints. Typical issues addressed by the Code Enforcement Officer include the following:
